Int. Keitel interview - day

## OFFICER KEITEL

CAROL ANDREWS

Henry was getting older he didn't fit in with that college crowd anymore and they didn't accept him as one of their own. So he began to recruit some other students.

The first two people he did recruit
were Robert and Joseph Mitchell.
He also recruited two medical
students: Stacy Eiffel and Elana
Shelton. Their role in this whole
story was to go out and become
friends with the young woman and
then they would give them a ride
back to the house. During that
span of seven years they had taken
about thirteen young woman back to
Henry's house and on August eighth,
nineteen-sixty-nine, that's when it
all stopped.

Well that's because this happened on August eighth, nineteen-sixty-nine, but on August ninth, nineteen-sixty-nine, that's when the Charles Manson murders took place.

CaROL ANDREWS (CONT'D)
Of course that was the story that
was published in the newspapers and
all over the TV. Who would want to
hear about a little town called
Windsor and the murders that took
place there?

Int. Robert's Interview - day

ROBERT ATWOOD (40s) sits in his home being interviewed. He's a normal Midwestern guy doing his best for the cameras. Unlike Keitel and Carol, he doesn't seem to be emotional at all.

Robert Atwood My name is Robert Atwood. I bought this house in eighty-eight at an auction.

ROBERT ATWOOD (CONT'D) I really didn't know much about the house but I'm pretty sure in the sixties, they had some pretty nasty things happened at that house. I was told this after I bought the house at auction, of course. After I started renting it out, I started getting calls from some of the tenants and they were telling me that they were having some weird things happen.

More footage of the present day house is displayed showing it's isolation.

ROBERT ATWOOD (CONT'D) They heard weird noises. Like one of them told me they heard a scream coming from the basement. So they started calling me freaked out that something was going on around the house. I had one guy call me and tell me that he saw five or six people in the living room. Then the next call I got from him was "I need to move out of here. Keep my deposit. I need to go." One time I heard some weird things down in the basement so I went down and investigated and then I heard something weird up in the living room. So I figured, maybe there was something to what these people were saying. So I decided to market it as a haunted house.

OffICER KEITEL

I realize that Mr. Atwood needs to turn a profit off his property but tearing it down and putting up a seven-eleven would be a better idea.

## Carol ANDREWS

They just want to tear this house down and want to forget and sweep all of the memories and the horrid stories under the rug. But thirteen young woman died there, including my sister and I really feel the house should be made a memorial to these young girls. We shouldn't forget them. I feel like they need to be remembered.
